#### Financials

As some of you know, the transition of the Foothills treasury function has been a lengthy one. Upon a vote of the Board, we have consolidated our Junior's checking account into the chapter's General Account. This eliminated the need to have two PayPal and Venmo accounts. I will continue to account for all income and expenses separately.

The Google sheets treasury worksheet can be accessed by Ana, Misty and I. Given the ongoing lack of customer service at Tri-Counties Bank, I recommend that we consider moving our account to Wells Fargo or another larger bank with a focus on business banking. I also suggest we consider streamlining our payment process by offering two options only - check or credit card, similar to how CDS handles annual membership payments. Our website would need modifications to be a "secure payment site" and clinic/show registrations could be handled with a link to the site. We could also pass on the 3-4% processing fee to the payee, as CDS and many small non-profits do with their credit card payments. I believe it's worth discussion.

Our bank and fund balances are fully and accurately reconciled. As of today, our financial snapshot is as follows:
